This claim is submitted pursuant to the provisions of § 110(a) and (d), and/or § 406(c) of the Indian Self-Determination and Education Assistance Act. This claim settles and resolves all claims identified in Section IV.A of the Final Settlement Agreement approved in *Ramah Navajo Chapter v. Jewell*, but does not include any claims specifically reserved in Section IV.B of the Final Settlement Agreement.

I hereby certify that the above claim is made in good faith, the supporting data are accurate and complete to the best of my knowledge, the amount requested reflects the compromise contract adjustment which I believe is due, and I am authorized to make this certification.
