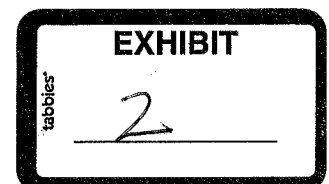

DECLARATION OF BRIAN DEVEAU (STATUS REPORT)

Comes now BRIAN A. DEVEAU, and being first duly sworn, states as follows:

1. I am a C.P.A and a Representative of Moss Adams, LLP (“Moss Adams”).
2. Moss Adams is the Class Monitor selected by Class Counsel and approved by the Court (Doc. 1358) to carry out the functions required by § VIII.F. of the Final Settlement Agreement (“FSA”).
3. Based on analysis of the bank statements for the Class accounts at the Huntington National Bank, the transactions in and out of those accounts as authorized by the various Orders of the Court, my work in verifying those reconciliations, and the



Settlement Administrator's findings respecting the following matters as reflected in the Declaration of Kenneth Jue filed April 9, 2018, I hereby confirm the following:

a) based on the statements provided by Huntington Bank, the interest and dividend earnings the Class received on the Class funds, Reserve account, and Attorney Fee account since they were deposited with the Huntington Bank and the other participating banks involved through March 31, 2018, total \$650,525.29. Based on my review of the bank statements, I have concluded that these interest and dividend earnings are materially accurate and were duly deposited into the Reserve Account in accordance with the banking arrangements approved by the Court.

b) As of March 31, 2018, based on the statements provided by Huntington Bank, the balance in the Designated Account was \$470,706.69. From this balance, the Class still has to (i) transfer \$322,259.60 to pay the last interpleader (Miwok); and (ii) pay \$148,447.09 for two resolved interpleaders on submission of the required Claim Forms. After these transfers and payments, the balance in the Designated Account will be zero.

c) As of March 31, 2018, the balance in the Reserve Account as reported on the bank statement provided to us by Huntington National Bank was \$3,984,032.51.

d) As of March 31, 2018, the balance in the Attorneys' Fees Holdback Account as reported on the bank statement provided to us by Huntington National Bank was \$1,000,000.

I declare under penalty of perjury under the laws of the State of Washington that the foregoing is true and correct and that this declaration was executed this 9th day of April, 2018, at Bellingham, Washington.
