There being no opposition to the entry of the following order, and the Court having previously approved individual settlements with the so-called DCA tribes and Red Lake Band of Chippewa Indians (Docket Nos. 454 and 274, July 18, 2000, and January 26, 1999, respectively), and the Court being apprised in the premises,

IT IS ORDERED, ADJUDGED AND DECREED THAT:


The Clerk shall, upon approval of the Final Distribution List by the Court, draw down from the CRIS Account No. 1:90-CV-0957-02 the following amounts and pay them to the respective tribes or tribal entities as indicated in the attached schedule, said payments to take place on or about the same time and in the same manner that the regular distribution to Class Members takes place:


A. Red Lake Band of Chippewa Indians - \$300,000.00


Class Counsel and the Independent CPA shall furnish the Clerk current mailing addresses for each of the entities to whom payments under this Order are to be made.
