Under paragraph 14 of Appendix F, and as further noticed to the Class in the December 16, 2003 mailing and in a subsequent mailing of December 19, 2003, all as addressed in the Certificate of Service filed December 23, 2003 (Docket 842 and 843), the thirty (30) day deadline for Class members to object to their "final share percentage" as set out on the said "Final Share Percentage Schedule" fell on January 19, 2004, a federal holiday, so the final deadline for filing such objections was January 20, 2004.
